ICR does research on crime prevention and criminal justice; disseminates information about human and victims' rights among all interested groups; supports public education aimed at increasing awareness about European values, promotes exchange of ideas and mutual help.ICR is involved in promotion of restorative justice in Bulgaria and training of mediators and is a member of the National Association of Mediators -Bulgaria. It is based on volonteers' commitment, funded mainly through projects and has a Chair, Board and General Assembly.

Prof. Dr Dobrinka Chankova is teaching Criminal Procedure Law, Human Rights Protection and Alternative Dispute Resolution at the Faculty of Law and History, South-West University - Blagoevgrad and Mediation in Penal Matters at New Bulgarian University - Sofia. She is a law graduate from Sofia University and has further specialised Criminology, Human Rights and Conflict Resolution at Columbia University - New York, Council of Europe - Directorate of Human Rights, European University Institute - Florence, etc. In 2009 she did research at Tokiwa International Victimology Institute – Mito, Japan. She has served as an expert at Human Rights Committee at the National Assembly and at the Council of Legislation at the Ministry of Justice of Bulgaria. Dobrinka Chankova has played a pioneering role in the introduction of mediation to Bulgaria's justice system, training of mediators and in increasing public awareness about crime victims protection. She has been a Bulgarian representative to the Council of Europe

Committees on Crime Problems and on Mediation in Penal Matters and a secretary of Bulgaria-EU Sub-Committee on Approximation of Bulgarian Legislation to the EC Law. She has lectured in numerous foreign universities in the framework of ERASMUS, INTERREG and other programs and has taken part as an expert and coordinator in various national and international research projects. Prof. Chankova has published widely in the field of restorative justice, victimology and human rights. She is a founder and chair of the Institute of Conflict Resolution.
