Jagiellonian University of Krakow is the oldest university in Poland. Founded in 1364 it was the second university in Central Europe, after Prague in 1348. Currently, the Jagiellonian University educates on the three levels: Ordinary, Masters, and Doctoral, following the principles of the Bologna Process. There are well over a hundred degrees and specialties available in Polish, as well as over a dozen in English. The European Credit Transfer System (ECTS) has been implemented in all courses and specialties, enabling trouble-free linking of studies at Jagiellonian University with studies in other European countries. The total number of students in 2012/2013 academic year amounted to 51,238, including 45,498 students, 3,092 PhD students and 2,648 post diploma students.

There are fifteen faculties at the Jagiellonian University, including three faculties which comprise the Collegium Medicum. On 31 December 2011 there were 6,947 persons employed at the University, including 3,723 academic teachers. The academic level of the University is indicated by the fact that almost every faculty has received category 1, the highest, in the official rankings of the Ministry of Science and Higher Education. Academics from the Jagiellonian University are effective in their competition for grants from European research programmes, and the University has several European Centers of Excellence.
